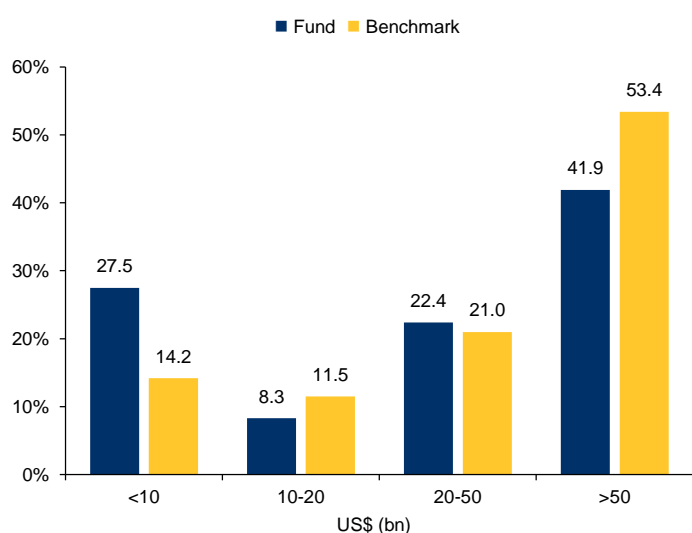

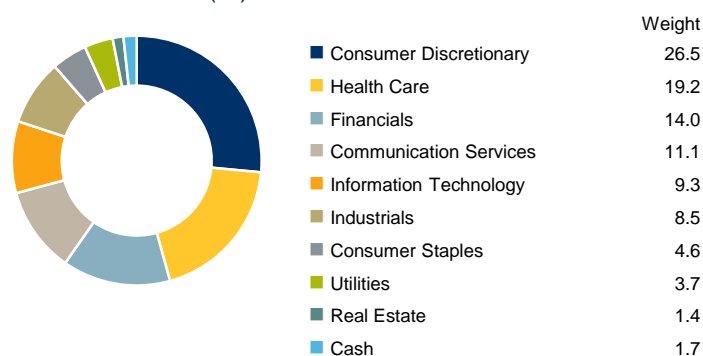
Market capitalisation distribution (%)
