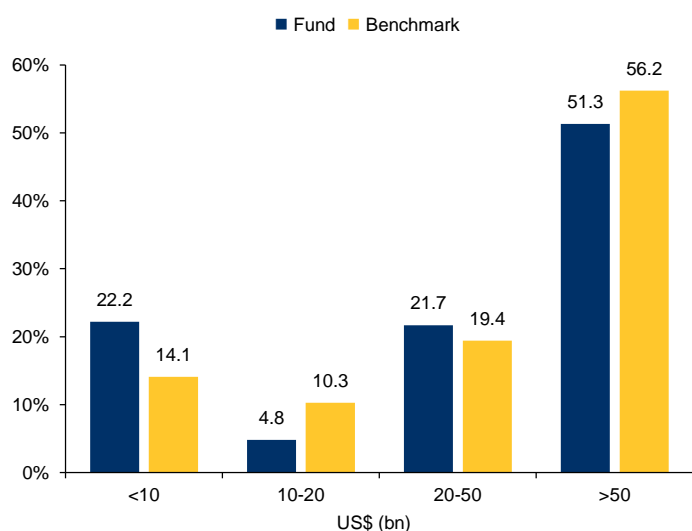

## Market capitalisation distribution (%)



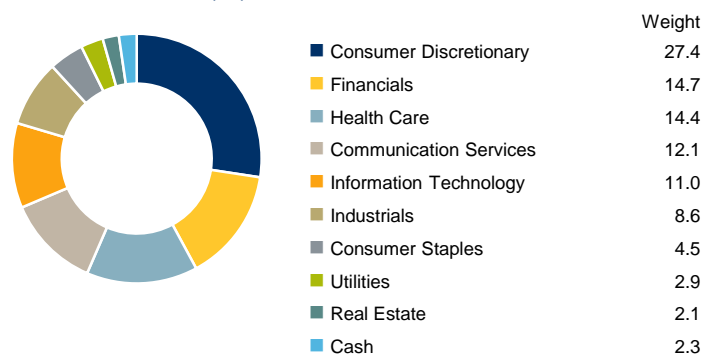
